APRIL 9, 2019

Meeting called to order at 10:00 A.M. by Supervisor, Johnson. Roll call showed members present, Johnson, Bindschatel, Dawson, Friedman and Goscicki. There were ten (10) citizens present. Pledge of Allegiance was said.

Bindschatel made motion, supported by Dawson to approve the agenda as presented with an addition, motion carried.

Goscicki made motion, supported by Friedman to approve the minutes of the March 12, 2019, Regular Meeting, motion carried. Dawson made motion, supported by Goscicki to approve the minutes of the March 28, 2019, Special Meeting, motion carried.

Guest Speakers: Tad Latuszek, Architect, spoke about updating the Master Plan. He will submit a proposal and retainer fee charges. Richard Castle, Consumers Energy Representative, spoke about the cost and amount of energy the growers need. Cost will be higher after 2019. Grants are available.
