REGULAR MEETING

MAY 11, 2021

The meeting was called to order at 10:10 a.m. by Supervisor Gabriel. Roll call with four (4) members present, Gabriel, Friedman, Richardson and Siwecki. There were two (2) citizens present Chief Pratt and Annie Goscicki. There were zero (0) video participants.

Zoning Enforcement: Zoning Enforcement opened a new case.

New Business: Friedman asked about how the Zoning Enforcing was going. Supervisor Gabriel said he had one new case open but was waiting until clean up days to give the residents a chance to clean up.
