## MICHIGAN PFAS ACTION RESPONSE TEAM TO UPDATE GRAYLING RESIDENTS ON PFAS INVESTIGATION

August 18, 2021 – An online meeting will be held on Thursday, September 9, 2021, from 6:00 – 8:00 p.m. for the Army National Guard and the Michigan PFAS Action Response Team (MPART) to update Grayling residents on the continuing investigation of PFAS contamination in private drinking water wells near Camp Grayling and the Grayling Army Airfield.

Representatives from the Army National Guard, District Health Department #10, and the Michigan Departments of: Environment, Great Lakes, and Energy (EGLE); Health and Human Services (MDHHS); Military and Veterans Affairs (DMVA); will host the meeting.
